

RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

By signing this Release, Waiver of Liability, and Indemnity Agreement, I acknowledge, that I am of lawful age; that I have read and understand the contents of this entire Agreement; that any questions that I may have had about this Agreement were adequately answered; and that I intend to enter into this Agreement voluntarily, without any undue pressure, compulsion, or duress, and to be legally bound thereby.

I represent and certify that I possess all necessary and appropriate licenses, to participate in the _____ motorcycle ride, (the "Ride"), organized by _____. I represent that I have not consumed any alcohol, ingested any drugs, medications or other substances that would impair me ability to participate in the Ride in a safe and lawful manner. I represent that I do not suffer from any medical conditions that would affect my ability to participate in the Ride in a safe and lawful manner.

I agree that I will comply with all laws, regulations, and rules of the road while participating in the Ride. I will familiarize myself with the route that the Ride will follow, understanding that the route may change at the discretion of the Ride organizers, volunteers, or authorized leaders without prior notice. I will read, listen to, and carefully follow all instructions by the Ride organizers, authorized volunteers and authorized leaders, prior to and during the Ride, remain alert, not become distracted, maintain safe and appropriate space between myself and others at all times, ride at safe speeds at all times, and not engage in any form of horseplay or reckless activity.

I agree that it is my sole responsibility, for myself and my passenger, if any, to select and properly wear such safety and protective clothing, apparel, garments, equipment, devices, guards, armor, and safety gear as required by law; or if not required by law, that I, in my sole discretion, deem to be safe and appropriate. I agree that it is my sole responsibility to provide a safe motor vehicle for the purpose of participating in the Ride, (or if I am participating as a passenger, that it is my sole responsibility to determine that motor vehicle on which I will ride is a safe motor vehicle), that the motor vehicle has all lawfully required licenses, inspections, and safety features; and that the motor vehicle has been inspected by a qualified person or persons to determine that it is mechanically sound and safe to operate in the Ride in all respects.

I represent and certify that I, and the motor vehicle that I will use in the Ride, have all insurance coverages required by law. I agree that operating the motor vehicle that I will be using in the Ride, (or that I will be occupying as a passenger); and, in addition, that participating in the Ride, are dangerous activities, which may result in serious permanent personal injury, disability, or death, and/or property damage.

I hereby agree to release, indemnify and forever hold _____, and _____, its/their officers, directors, employees, agents, members, organizers, volunteers, affiliated organizations, and representatives, harmless from any and all liability to me, my personal representatives, heirs, administrators, successors, assigns, next of kin, and estate beneficiaries, and forever give up any claim or demand therefore, in law or in equity, including but not limited to claims for contribution or indemnity, for any injury, damage or loss to person or property growing out of or connected in any way with the Ride, whether foreseeable or not, and WHETHER OR NOT, OR EVEN IF CAUSED BY THE ACTIVE OR PASSIVE NEGLIGENCE of _____, and/or the _____, its/their officers, directors, employees, agents, members, organizers, volunteers, affiliated organizations, and representatives, or otherwise, to the fullest extent permitted by law.

I agree that this Release, Waiver of Liability, and Indemnity Agreement is intended to be as broad and inclusive as permitted by the law of the Commonwealth of Pennsylvania and that if any portion thereof is held to be invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. I agree that this document contains the final and entire agreement, and overrides any other oral or written statements, and that I am not relying on any oral representations, statements, or inducements apart from or not contained in this Agreement.
